**DOG LICENSING REMINDER,** especially to those who have had their taxes paid via an escrow payment. Dog licenses expire on 3/31/2024. Please remember to include a current certificate of vaccination for man's best friend in order to be issued license and tag!



**Chicken Permits**- the village ordinance #250 allows for four hens to be kept according to the rules set forth in the ordinance. A complete copy of the rules can be seen on the village website. Those permits are valid from Jan. 1 to Dec. 31, and must be renewed annually if you are a chicken keeper! Water rate utility increase will be taking effect with the February bill. Please keep your account current. In an effort to save on expenses, please consider signing up for emailing of the monthly bill, along with signing up for auto-withdrawal.

ALL PROPERTY MAINTENANCE COMPLAINTS MUST BE IN WRITING, and will only be considered if it is submitted. The form is available on the website or at the village office. Please drop in box outside or in the hallway, or mail/email them to the office. If you have concerns, please contact a member of the board.

**Recycle and Trash site** is open Wednesdays from 5 pm to 7 pm and Saturdays from 9 am to 1 pm. A 13 gallon/ regular kitchen bag is \$3 and a 30 gallon/large bag/barrel is \$5. *Please have small bills/exact change when paying for the disposal of your trash.* As always, recyclables are free to dispose of. The site is at the shop, by the water tower, on the southeast corner of the village. If you wish curbside service, then you must contract it independently.

Compost Site-Christmas trees are accepted at the compost site. The village does not offer curbside collection.
