Village Hall—Clerk/Treasurer Office Hours: Monday-Wednesday, 7:30am to 2:00pm.; Thursday, 7:30am to 11:30am and closed on Friday. If I happen to be out of the office, I am generally out on an errand which includes the bank, post office and trips to the shop. There is a white drop box on the north side of the building to deposit your utility bills, tax payments, and other correspondence in. If you wish to get a receipt, please indicate that on the payment. Remember this is a “one person” office.

Shop Hours: The DPW employees work Monday-Thursday from 6:00am to 3:30pm and on Friday morning. They are always on call for an emergency if necessary.

Library Hours: Monday-Thursday 11:00am to 5:00pm and Friday 12:00pm-4:00pm.

REMINDER—NO PARKING (ord. # 247) is allowed on the streets in the village from midnight to 7:00am from November 1st to April 1st. There will be a forfeiture of \$25 per offense if paid within five days; otherwise, a citation with a court date and further costs will be issued. This allows for snow removal! Snowplowing starts very early in the morning before many of us have gotten out of bed, so that we can get to work and school! Your full cooperation is appreciated!

House Numbers- A letter will be sent out with the December utility bills to residents who do not have house numbers properly displayed on their homes. Please get this taken care of right away.

CAUCUS- A caucus will be held tentatively on 1/12/26 at 4 pm prior to the regular village board meeting to nominate candidates for the ballot. The village has a five-person board, with alternate year elections. Two village board seats (incumbents William McCarron and Tyler Lemke) will be nominated.

Election Dates for 2026:

- February 17- Spring Primary if needed
- April 7- Spring Election
- August 11- Partisan Primary
- November 3- General Election

Absentee voting- you need to **RE-APPLY** for absentee ballots **EVERY** year unless you are considered an “indefinitely confined” voter. Go to My vote Wisconsin site to apply.

Nutrition Site at Centennial Hall- Our very own Jean Czerniak cooks fresh, hot, and delicious Senior meals. You must call the hall by 2:00pm the day before to reserve your meal—715-678-2000. The cost is \$5.00 per meal and well worth it!! **Dining in is offered every Tuesday and Thursday with lunch served at 11:30.** Carry-outs are also available. On days that meals are **NOT SERVED** at Centennial Hall, you may dine at the Medford site on the fairgrounds. Anybody over 55 years young is eligible to join in the activities offered by the Taylor County Commission on Aging. Call 715-748-1491 to sign up for their monthly newsletter either by mail or email. Bus rides are also available to Eau Claire & Marshfield for shopping for a nominal fee. Take advantage of these programs offered by the Taylor County Commission on Aging!

Real Estate Taxes- Tentatively, tax bills will be ready to be mailed after December 8th. 1st payments are due locally by January 31, 2026. Any payment in the mail or courier box on Monday, 1/5/2026, morning will be received as of 12/31/2025 for tax purposes. The 2nd payment is due by July 31, 2026 to the Taylor County Treasurer. **If you need a receipt, please enclose a self-addressed stamped envelope or include your email address.**
