Your 1st or full tax payment may be deposited in the white drop box located on the north side of the Jean M Thomsen Memorial Library, or put in the slot by the office door, or mailed to:

Village of Stetsonville, PO Box 219, Stetsonville, WI 54480.

The 1st installment is due to the Village Treasurer by 1/31/2026. Any payments in the courier box on Monday, 1/5/2025 will be receipted as of 12/31/2025, including those with postmarks of 12/31/2025 or earlier for 2025 tax purposes.


The 2nd installment is due to the Taylor County Treasurer by 7/31/2026.



Proof of current rabies vaccination must be provided in order to obtain a license. Any dog license not paid by April 1, 2026 will be turned over to the Taylor County District Attorney for collection and a fine of \$169. If you have rental properties in the Village, remind your renters they need to license their dog(s). State statute 174.05 requires dogs over 5 months in age to be licensed.



Garbage/Recycling is open every
Wednesday 5pm-7pm & Saturday 9am-1pm
3.00/13 gallon bag (kitchen bag) or less;
\$5.00/large bag or barrel (note change)
Recyclables are free!



Don't Flush Trouble- If it's not human waste or toilet paper, it's trouble! Use a trash can to dispose of grease, used wipes, hygiene products, and hair. The product label might say "flushable" but disposable wipes can damage pumps and clog sewer lines.



Remember to keep your past due water/sewer bill below \$300 to avoid receiving a disconnection notice. Landlords, please inform your tenants of this policy. Payments can be made via auto-withdrawal, mail, or drop box. Payments are due at the end of the month-late charges will be assessed!

Please obey the signs at the compost site and only dispose of brush and leaves. <u>DO NOT</u> leave items such as: plastic flower baskets or trays in the compost pile--- those items belong in the garbage.



From November 1st thru April 1st

There will be no overnight street parking from midnight until 7am so streets can be plowed. Do not plow snow into village streets and keep your sidewalks clean.



County Treasurer advises USPS policy change on postmarks may affect tax payments

Taylor County Treasurer Sarah Holtz is encouraging residents who pay their property tax bills by mail to be aware of a recent U.S. Postal Service policy change that may affect when envelopes are postmarked.

In August 2025, the Postal Service instituted a nationwide change as to when a postmark is affixed to incoming mail. Instead of postmarks being affixed when the item is first touched by the Postal Service, postmarks are now stamped at regional sorting centers.

That means your postmark could be several days after you put it in your mailbox. In other words, if you plan to pay your property taxes by mail, don't wait until right before the deadline to put it in the mail.

Federal and State laws define timely payment based off the USPS postmark, meaning payments may be considered delinquent if they are mailed too close to the deadline – even if they were, in fact, placed in a mailbox before the deadline.

To avoid this issue, Holtz encourages Taylor County property taxpayers to mail payments earlier to avoid becoming delinquent and accruing substantial late fees.

Holtz cautioned taxpayers about sending tax payments utilizing their personal bank's online bill payment option as those payments are often done in bulk with many other customers' payments, so there is a danger those could arrive late and become delinquent as well. This type of payment has become even more problematic in recent years as the time it takes for USPS items to arrive at its destination after mailing has increased, Holtz added.

Another option could be to physically bring your payment into the post office and request that they postmark your payment in front of you or by sending it certified mail.
